WHEREAS, the Village Board acknowledges the Plans and Specifications have been submitted to New York State Environmental Facilities Corporation and New York State Department of Environmental Conservation for review and approval; and

WHEREAS, the Village Board anticipates imminent final approval of the Plans and Specifications by New York State Environmental Facilities Corporation and New York State Department of Environmental Conservation; and
