7C. Chief Jory briefed the board on the upgrade to the Camera System at Village Hall. The estimate was around \$12,000.00 dollars and ARPA Funds would be used. The Mayor and myself met with Central Security to look at the cameras that were part of the LED upgrade and was advised the equipment is out dated and not efficient in any way. Mayor Sherry asked that

Attorney Rossi be apprised and see if there is anything we can do. We tried to get out of the contract when I became Mayor she said. It turned into a very costly inefficient project. Motion by Trustee Scalise second by Trustee Dhaniram and carried to move forward with both the village hall system and Attorney Rossi looking into LED Lighting Grant that added the cameras.

#### **8. NEW BUSINESS**

- **\_8A.** The bid for the **garbage contract** was explained by Josh Olbrys from Herkimer Oneida Solid Waste Authority. We only had two bidders and one bidder did not follow the bid specs so that left just one which is Spohn's, who has the contract now. The rates are going up but they are the only contractor's willing to do green waste, electronics and also big items weekly. The board can cut services to try and reduce the increase he said. He also said they can put stipulations in the contract for when the village has to clean up mess they leave behind when collecting. On a motion by Trustee Dhaniram second by Trustee Scalise and carried to award the garbage contract to Spohn's with stricter contract language so village can bill for cleanup.
- **8B**. On a motion by Trustee Scalise second by Trustee Ainsworth and carried to hire **Alexander Scholl as a Firefighter Recruit** as recommended by Fire Chief Mike Spisak. He will follow the Firefighters Contract.
- **8C**. On a motion by Trustee Dhaniram seconded by Trustee Scalise and carried to approve Water/Sewer Superintendent Matt Spisak to **advertise for a position** in the Water/Sewer Department.
- **8D.** The Clerk Treasurer's request to **advertise for an Office Clerk** was approved on a motion by Trustee Scalise seconded by Trustee Dhaniram and carried.
- **8E**. On a motion by Trustee Ainsworth seconded by Trustee Scalise and carried to give a **3% raise** to Street Superintendent Justin Cristman and Deputy Treasurer Paula Dygert, and an **8% raise** to Police Chief Michael Jory.
